Motion made by Hubbard, seconded by S. Boyl to approve the minutes of March 13, 2025 meeting as presented. Motion carried.

**Public Comment:**

Ted Patrick informed the Board that he would like to resign as Siple Cemetery Sexton within the next couple of months to give the Board time to find a replacement.

Dennis Traxler recommended that Ted Patrick be given recognition for all his years as Siple Cemetery's Sexton. The Board agreed and thanked Ted for all his years of hard work and dedication.

**Treasurer's Report:**

Motion made by Kelly, seconded by J. Boyl to approve the Treasurer's report with an ending balance of \$396,954.53 in the General Fund as of March 31, 2025. Motion carried.

Motion made by J. Boyl, seconded by Hubbard to pay bills in the amount of \$14,716.20 for April 2025. Motion carried.

The Covid CD account has been closed. The funds were issued into a bank money order and paid to the Tuscola County Drain Commission in the amount of \$87,187.50.

A new Road Account was set up at Tri-County Bank to hold all road millage monies. The millage money in the amount of \$209,461.97 was transferred from the General Fund into the new Road Account.
