

April 11, 2019
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Boyl and Thom. 4 other township residents present. 2 Dayton township residents present and Jay Tuckey from the Tuscola County Road Commission also present.

Motion made by Boyl, seconded by Jobson to approve the minutes of March 14, 2019 meeting as presented. Motion carried.

Jobson presented the revised Treasurer's report for March 2019 with ending balance of \$224,806.89 to reflect March's interest income.

Motion made by Vroman, seconded by Thom to approve the Treasurer's report for April 2019 with an ending balance of \$204,838.02. Motion carried.

Kramer noted that there would be a tire collection at Dayton Township hall on May 24, 2019 available for all Tuscola County Residents.

Public Comment: Dayton Township residents spoke regarding objection to the brush and tree removal along English Rd in Section 18. Board responded stating that Section 18 is not Koylton Township's responsibility and that the township did not do any cutting in that section.

Jay Tuckey from the Tuscola County Road Commission spoke regarding a grant program proposal for roadside brush spraying in the road right of way at no charge to the township. He said that there would be public posting notice in the Tuscola County Advertiser and also that no spray forms would be made available for residents who request to opt out which will need to be returned by June 1st, 2019.

Motion made by Thom, seconded by Boyl to accept the County Road Commission proposal for roadside brush spraying in the road right of way at no charge to the township with suitable mailing notification to township residents. Motion carried.

Kramer stated that there will be a hearing April 18, 2019 at Marlette Township Hall regarding the Murdick-Van Sickland Intercounty Drain.

Kramer read a letter he wrote to Edward McGinnis thanking him for his years of service to the township on the Board of Review. All board members present signed the letter.

Kramer gave an explanation as to the pre-payment amount paid (\$8,025) to Wilkinson Corporation for brining of gravel roads.

Kramer presented road bid estimates for proposed road work on Phillips Rd, Cartwright Rd, Mayville Rd, White Creek Rd with explanation and discussion by board to follow.

Motion made by Jobson, seconded by Thom to approve Albrecht Sand & Gravel to place 1000 ton of 23A at cost of 13.50 per ton (\$13,500) on Brief Rd between White Creek Rd to Marton Rd. Also, to place 500 ton of 23A at cost of \$6,750 on Denhoff Rd west of White Creek approximately a ¼ mile. Motion carried.

Motion made by Boyl, seconded by Kramer to adopt the Garbage Collection Budget for 2019-2020 for \$97,300.20. Motion carried.

Motion made by Kramer, seconded by Boyl to amend resolution 19-02 Treasurers Salary not to increase to \$14,400 but to remain at \$12,000 annually due to financial considerations by Linda Jobson for her benefit not to take the raise at this time. Motion carried.

Motion made by Kramer, seconded by Jobson to amend and adopt the 2019-2020 township working budget to reflect March's interest income and expense line item changes: Township Board increase from \$6,000 to \$7,000, Treasurer Salary decrease from \$14,400 to \$12,000, Computer Fund increase from \$3,000 to \$3,200, Contingency Fund increase from \$10,000 to \$12,000. Motion carried.

Public Comment: Ron Coltson stated that the Marlette Fire Department pending purchase of used Ladder Truck has passed all inspections and that there are three banks submitting financing bids for negotiating financing terms.

Motion made by Boyl, seconded by Jobson to pay township bills of \$20,138.87 for April 2019. Motion carried.
