April 13, 2023 Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Boyl, Sabin and Blonde. 9 other members present.

Motion made by Boyl, seconded by Sabin to approve the minutes of March 9, 2023 meeting as presented. Motion carried.

Motion made by Boyl, seconded by Sabin to approve the Treasurer's report for April 2023 with an ending balance of \$37,185.48 with additional funds to transfer later from Tax Fund Account. Motion carried.

Motion made by Vroman, seconded by Kramer to approve and accept the 3 year contract (2023-2025) from Discrete Services at \$5,600 per cut for roadside mowing. Motion carried.

Motion made by Blonde, seconded by Boyl to approve and accept the Fire Service Contract from the Village of Kingston Fire Department in the amount of \$20,080 paid quarterly at \$5,020 for 3 years commencing July 1, 2023 to June 30, 2026. Motion carried.

Motion made by Boyl, seconded by Kramer to accept the contract for brining of township gravel roads from Wilkinson Solutions at \$9,265 per application and pay a deposit of \$3,500. Motion carried.

Motion made by Blonde, seconded by Boyl to approve and accept the Village Hall Lease agreement for 3 years, renewable yearly, with base rent of \$7,500 for 3/1/23-2/28/24 and \$8,000 for 3/1/24-2/28/25 and \$8,500 for 3/1/25-2/28/26 paid quarterly to the Village of Kingston. Motion carried.

Discussion followed by the board with Kramer appointing Boyl to head a committee to explore the cost and size of a building for a township hall.

Kramer noted that the Tornado Siren has been installed and tested and will be connected by DTE to the transformer within a week.

The proposed road work contracts for 2023 were tabled for further verification of roads listed and extent of work.

Public Comment:

Leonard Vanderploeg voiced a complaint regarding neighbors six hound dogs barking as a nuisance. Kramer advised CCO to investigate as zoning allows for only four dogs without a kennel license.

Motion made by Vroman, seconded by Blonde to approve land division split for Buddy Thomas parcel ID #016-006-000-1900-01. Motion carried.

Motion made by Blonde, seconded by Boyl to change the next regular township board meeting date from Thursday May 11 to Tuesday May 16. Motion carried.

Motion made by Blonde, seconded by Vroman to approve and accept the Marlette Fire Authority Contract for Standby fee of \$11,996.52. Motion carried.

Motion made by Blonde, seconded by Kramer to pay township bills of \$24,277.30 for April 2023. Motion carried.
