Meeting called to order at 7 pm by Supervisor Kramer.

Pledge to the flag.

Kramer Read December minutes, revised to read trees will not be marked only by Kramer, but he will go with Boyl and Kappen to mark trees.

Motion made by Blonde, seconded by Boyl to accept the December minutes with revision. Motion carried.

Blonde read treasurers report.

Motion made by Kramer, seconded by Boyl to approve the Treasurer's report for January. Motion carried.

Blonde stated that there is money in the Tax fund for garbage now, but consensus was to continue to use GF dollars until settlement in March.

Brian McGinnis, Police Chief from Marlette, presented information regarding the officer within the Marlette school district and discussed complaints. Looking for funding for the Officer within the School. Koylton is the second largest entity that has students in the Marlette school district. Asking for \$50 per student attending from Koylton Township to help support this program. One year \$4000 and \$12,000 for three years.

Discussion: Kramer concern of number students coming from Marlette to Kingston. It was explained and clarified that we can spend ARPA Relief in this way and can support this. It was tabled for further discussion at the February Meeting.

Bid from Wilkinson for brining- \$9,265.00. No discount for paying ahead.

Check Received. For \$2,850 was collected for Fire Run on Philips Road.

Roads addressed for possible road work:

- All roads mentioned from the December minutes will be considered.
- Jim and Linda Borek, Livermore to be considered for gravel
- Schank and McGinnis, Cemetery Road -Marlette to Harris Road (2 miles) very large berm on the edge of the road. Can they do similar to Centerline where it was pulled in and re-worked. Is it possible to make more narrow?

Supervisor Kramer will request the estimates for these roads from the Road Commission.

Mark Schank, Burlington Township Fire Chief provided the Burlington Fire Contract. The contract will tentatively be approved at the February meeting. It is a 2 year contract, no changes in fees.

Complaints received regarding the increase in dumpster fees were discussed.

Kramer made a motion to pay the bills for January of \$20,549.67 Blonde Support, motion carried.
