Supervisor Kramer called the meeting to order at 7:02 pm.

Supervisor Kramer read the meeting minutes. Change requested to retract word "members" in 3 other members present. Motion made by S. Boyl and supported by J. Boyl. Motion carried.

Treasurer read the treasurers report, General Fund balance ending \$169,989.63, motion made with updates as discussed (fix balances at the top) and paying garbage for June July and August. Motion made by Justin Boyl and Supported by Sabin, motion carried.

Justin Boyl made motion to accept nomination of Ray Atalato to fill the position on the Planning Commission, Kramer supported and the Motion carried.

Drain commission changing some lines, meeting was held today.

Road Commission, road work is complete.

Mowing is complete, he discounted the bill by \$100. Kramer made a motion to add a check to the expenses pay Discrete Diesel for Roadside Mowing for \$5,500. Supported by Shari Boyl. Motion carried.

Tim/Joel- Tornado Siren. Discussed the issue with siren, dead spot from the Sandusky at 300W. Clio is 1000 W and 30 miles away. Tech was here today and switched us to the Clio station. In addition, Joel found that there is a test available weekly on Wednesday. There is a numerical LCD that you can check the counts. We have it set at 11-1 on Wednesday and it is set to go off for what is called a Growl Test. There is a 2 second rotation. This is a radio test for the NWS. Joel is studying tornados at Oklahoma State in Tornado Alley. Elliot and Justin will do their due diligence to check the siren to determine rotation. Our siren is the only siren in the state that runs off the NWS. Only Gagetown, runs off the central dispatch.

Survey for hall millage was presented by Supervisor Kramer, opinions were asked. No objections to the letter Kramer presented. Timeline survey due by 9/1 and if a positive approval, then put the millage on the November ballot. Clarification that this is for a building millage and will not affect the road millage funds. Shari and Deputy treasurer will work to send out the letter by end of the month.

Nick Osentoski/Discrete Diesel came to discuss size of rocks on the side of the road, as well the brush encroachment on the back roads.

Kramer made a motion to pay the bills in the amount of \$32,035.18 and J Boyl Supported. Motion passed.
