## March 12, 2020 Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:05 pm.

Board Members present: Kramer, Vroman, Jobson, Boyl and Sabin. 12 other township residents present.

Motion made by Sabin, seconded by Kramer to approve the minutes of February 13, 2020 meeting as presented. Motion carried.

Kramer reported on the safety concerns of wintertime road conditions on Mayville Rd. He stated that the Road Commission declined any proposal request for plowing & salting the road and that Wilkinson Corporation doesn't brine in the winter. Kramer mentioned considering a private plowing service with special permit issued from the Road Commission.

Kramer reported that the Board of Review went well.

Vroman reported that the election Tuesday went well even with the new QVF Refresh software and law changes with same day voter registration and AV ballots returned day of election.

Motion made by Vroman, seconded by Kramer to accept the letter of resignation from Rob St. George as Code Compliance Officer effective March 12, 2020 with reservation. Motion carried.

Kramer stated that he received a bid for roadside mowing from Roadside Maintenance. No action taken will discuss next month.

Ron Coltson reported that the Marlette Fire Department has sold all the trucks and plans to paint the fire hall. He stated that all of the five entities of the Marlette Fire Authority received some reduction in standby fees for the upcoming year. Kramer noted that Koylton Township's cut would be about \$2,000 less.

Motion made by Jobson, seconded by Sabin to accept Opperman Library contract for 2020-2021 for \$500.00. Motion carried.

Motion made by Boyl, seconded by Sabin to approve the Treasurer's report for March 2020 with an ending balance of \$68,787.62. Motion carried.

Motion made by Kramer, seconded by Jobson to adjust the 2019-2020 budget by transferring \$5,200 from the Contingency fund to Drain at Large line item. Motion carried.

Motion made by Boyl, seconded by Sabin to adjust the 2019-2020 budget by transferring \$300 from the Contingency Fund to the Election line item. Motion carried.

Motion made by Vroman, seconded by Kramer to adjust and amend the 2019-2020 budget by transferring \$100 from the Contingency fund to Treasurer Wages line item to reflect all changes made and adopt the 2019-2020 budget as presented with amendments. Motion carried.

Motion made by Vroman seconded by Kramer to approve land division application for Elliot Hubbard, parent parcel #016-019-000-0200-03 into two parcels for building site. Motion carried.

Kramer stated that he is checking on finding a person to assist in documenting cemetery records for Siple Cemetery.

Motion made by Boyl, seconded by Jobson to pay township bills of \$228,109.01 for March 2020. Motion carried.
