The regular Koylton Twp meeting was called to order by Supervisor Justin Boyd at 7:02 pm. Pledge to the Flag. Board Members present: J. Boyd, Kelly, S. Boyd, Hubbard, Sabin

Motion made by Kelly, seconded by Hubbard to approve the agenda as presented. Motion carried.

Motion made by Sabin, seconded by Hubbard to approve the minutes of February 13, 2025 meeting as presented. Motion carried.

Public Comment:

Ron Coltson stated this was his last month with the Marlette Fire Authority. The Board thanked him for all of his years of service.

Treasurer's Report:

Motion made by Kelly, seconded by Sabin to approve the Treasurer's report with an ending balance for February in the General Fund of \$176,580.27. Motion carried.

Motion made by J. Boyd, seconded by Hubbard to pay Tuscola County Road Commission final payment for 2024 road work in the amount of \$73,519.88 on March 2025 expense report. Motion carried.

Motion made by S. Boyd, seconded by Sabin to pay remaining township bills of \$23,399.47 for March 2025. Motion carried.

Supervisor's Report:

J. Boyd stated that the Road Commission offers a no cost Management Plan. If the Township is interested, they will come present the plan in the Fall. The Board agreed it was in the Townships best interest to discuss the Road Commissions Management Plan.

J. Boyd stated he received two separate bids for Tree Trimming which included all of Clothier Rd from M-46 to Marlette Rd and a section of White Creek Rd from Centerline to Marlette Rd. Bids were received from Kappen Tree and Flynn's Tree Service.

Motion made by Hubbard, seconded by S. Boyd to approve tree trimming work to be done by Flynn's Tree Service on Clothier Rd from M-46 to Marlette Rd with a maximum amount of \$24,000.00, Any remaining monies are to be used towards White Creek Rd from Marlette Rd to Centerline Rd. Motion Carried.
