

May 16, 2023
Koylton Twp Board Meeting

APPROVED

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:05 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, J. Boyd, Sabin and S. Boyd. 4 other members present.

Motion made by S. Boyd, seconded by Kramer to approve the minutes of April 13, 2023 meeting as presented. Motion carried.

Motion made by Sabin, seconded by Kramer to approve the Treasurer's report for May 2023 with an ending balance in the general fund of \$314,575.18. Motion carried.

Mark Schank, CCO reported that the issue regarding the six hound dogs barking as a nuisance has been resolved. The owner has decided against applying for a kennel license and is getting rid of the hound dogs.

Motion made by J. Boyd, seconded by S. Boyd to sign and approve the Road Commission road work contracts for the following gravel roads at a total bid of \$215,050. Motion carried.

Motion made by J. Boyd, seconded by S. Boyd to appoint Larry Sabin as the Marlette Fire Authority Representative for Koylton Township and to pay him \$35 per meeting plus mileage. Motion carried.

Motion made by J. Boyd, seconded by Kramer to accept the resignation with regrets of Rodney Friday, Jr. as Planning Commission Chairperson. Motion carried.

Motion made by S. Boyd, seconded by Vroman to approve the recommendation from the Planning Commission to appoint Elliot Hubbard as Chairperson. Motion carried.

By Board Consensus, Vroman to purchase a new computer for the Clerk and the Planning Commission Secretary.

J. Boyd reported that the Planning Commission Hearing for the four ordinances, (RV, Small Animals, Shipping Container and Cost Recovery Ordinances) went well and that there were some minor changes made and will be presented to the Board next month.

Motion made by Kramer, seconded by S. Boyd to pay the Road Commission the 50% deposit required for roadwork of \$107,525. Motion carried.

Motion made by J. Boyd, seconded by Sabin to pay township bills of \$11,262.41 for May 2023. Motion carried.
