

October 11, 2018
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm.

Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Boyl and Thom.
7 other township residents present.

Motion made by Boyl, seconded by Jobson to approve the minutes of September 13th, 2018 meeting.
Motion carried.

Motion made by Vroman, seconded by Thom to approve the Treasurer's report for October 2018 with an ending balance of \$184,452.10. Motion carried.

Kramer reported that the roadside mowing was completed and also that the brining of Mayville Road, Marlette Road and the Limestone roads was done.

Kramer reported that Lehn King would be at the November meeting to present quotes for annual audit.

Motion made by Thom, seconded by Jobson to adopt the Garbage Collection Budget for 2018-2019.
Motion carried.

Thom reported that Kappen Tree Service completed the large tree and brush removal along Cemetery Road between Denhoff and Cartwright Roads and Cartwright Road between Cemetery and Kingston Roads.

Kramer reported that there were concerns of roadside safety on the hill by Dr. Robbins property on Cartwright Road.

Public Comment:

Ted Patrick, Siple Cemetery Sexton stated that he mowed the cemetery in October and that Marsh Funeral Home is charging \$500 for grave site opening. He also said that the price to purchase grave sites for township residents is \$350.

John Flikkie addressed his concerns regarding road safety with the farmers spilling manure and heavy mud into roadways from the fields. Thom will communicate with the farmer. Also, Kramer suggested contacting road commission.

Motion made by Thom, seconded by Boyl to pay township bills of \$21,032.20 for the October 2018 expenses. Motion carried.
