

September 14, 2023
Koylton Twp Board Meeting

APPROVED

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, J. Boyl, Sabin and S. Boyl. 6 others present including Kim Vaughn, county commissioner.

Motion made by S. Boyl, seconded by J. Boyl to approve the minutes of August 10, 2023 meeting as presented. Motion carried.

Motion made by J. Boyl, seconded by Sabin to approve the Treasurer's report for September 2023 with an ending balance in the general fund of \$211,163.29. Motion carried.

Public Comment:

Bill Runge presented a request as representative for Evelyn Runge, his cousin for a proposed 320 amp Electrical Service with documentation and load calculation form for home and Ag barn usage located at 4004 Clothier Road, Kingston. The Board reviewed the information.

Motion made by J. Boyl, seconded by Kramer to approve the request for a 320 amp electrical service for Evelyn Runge located at 4004 Clothier Road, Kingston for house and Ag barn usage. Motion carried.

Mark Schank, CCO phoned Attorney Jim Abbey regarding a Blight issue for advice.

Kim Vaughn, county commissioner addressed the board and those present regarding the Resolution passed by the County Commissioner Board Opposing any Legislation preempting local control for Solar and Wind Developments.

Kramer noted that there is a special attorney that was hired to handle the State Tax Appeals Case for Nathan Hager, township assessor.

Kramer reported the results of the township survey mailing for the possibility of proposing a millage for a new township hall, 150 No to 38 yes votes. Other hall and space discussions followed.

Elliot Hubbard planning commission chair mentioned that there will be a special hearing next week Thursday the 21st for a dog kennel request.

Motion made by Kramer, seconded by S. Boyl to approve the request for a PA 116 on parcel ID #016-001-000-0100-00 for DRC Land LLC. Motion carried.

Vroman mentioned that the county is working on agreements to consolidate townships for the 9 days of Early Voting for next year Presidential Primary in February.

Vroman stated that he is checking with King & King CPA's regarding the 941 tax statements and payment frequency.

Motion made by Kramer, seconded by Vroman to pay township bills of \$6,271.77 for September 2023. Motion carried.
