

April 9, 2020
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Sabin and Boyl via facetime.

Motion made by Jobson, seconded by Sabin to approve the minutes of March 12, 2020 meeting with correction of Treasurer's Report ending balance to read \$68,787.62 and wording change for finding a person to assist in documenting Siple Cemetery records. Motion carried.

Jobson presented the revised Treasurer's report for March 2020 with ending balance of \$68,787.62 to reflect March's total interest income.

Motion made by Vroman, seconded by Sabin to approve the Treasurer's report for April 2020 with an ending balance of \$50,267.75. Motion carried.

Motion made by Boyl, seconded by Jobson to amend and adopt the 2020-2021 township working budget to reflect revision of balance on hand \$68,787.62 due to March's total interest income and prepayment from 2019-2020 budget for deposit on road work for the 2020-2021 season and expense line item change for Roads to \$255,000 due to prepayment. Motion carried.

Motion made by Jobson, seconded by Sabin to adopt the Garbage Collection Budget for 2020-2021 for \$97,454.40. Motion carried.

Motion made by Vroman, seconded by Kramer to accept the contract for brining of township roads from Wilkinson Corporation and pay the deposit requested. Motion carried.

Kramer noted that if anyone calls or contacts any board members regarding tire collection to have them call Kramer for further information.

Motion made by Boyl, seconded by Jobson to approve the wording for the Koylton Township, Improvement And Maintenance of Roads Renewal Proposal, thereby to place a 2 mill renewal for road improvement and maintenance proposal for 4 years (2021-2024) on the August ballot. Motion carried.

Jobson reported to the board to expect a decrease in interest income from bank accounts due to rate adjustment and lower balance.

Motion made by Vroman, seconded by Boyl to pay township bills of \$18,669.87 for April 2020. Motion carried.
