

December 13, 2018
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:03 pm.

Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Boyl and Thom.
9 other township residents present.

Motion made by Boyl, seconded by Jobson to approve the minutes of November 9th, 2018 meeting as presented. Motion carried.

Treasurer Jobson read the Treasurer's report for December 2018, additional expenses need to be added, delayed approval until later.

Discussion regarding road brush/tree cutting bids. Thom and Kramer reported that only one company out of three contacted had submitted a bid by deadline date. Ben King from King's Stump Grinding was present and presented his bid to clear brush and trees.

Motion made by Kramer, seconded by Jobson to contract with King's Stump Grinding for \$20,500 to clear brush and trees along the following roads; Livermore Rd (Phillips to English), Phillips Rd (Denhoff to M-46), English Rd (Snover to Livermore-east side only), Mayville Rd (Kingston to Cemetery), Cemetery Rd (Mayville to Lanway ½ mile), Lanway Rd (Cemetery to Kingston) and Lanway Rd (Kingston to Phillips, not to exceed \$2,000). Motion carried.

Public Comment:

Lehn King presented and clarified options and cost for completing township's annual audit and F-65 report filing with discussion by board regarding moving audit to election off-year. King to submit official contract agreement for annual audit by next month's township board meeting for board to act on.

Jeff Mallory, Kingston fire chief, was present and addressed the board. He commented that the township contract for fire protection will remain the same with no increase for another three years. An official contract will be mailed later. He stated that next year's budget will not have an increase. Also, that the 2003 Fire Engine will be paid off this year. He also explained how they have cut the Medical Unit runs down this year to priority runs only and grant monies received over the past years.

Jobson commended Kramer on his part in contacting the County Road Commission regarding getting holes filed in on Mayville Road.

Ron Coltson from Marlette Fire Department stated that the used Ladder Truck came back on the market that the department was considering and that there is only one entity (Elmer Township) left of the Marlette Fire Authority to approve the department to pursue the purchase of a used Ladder Truck. Ron stated that Elmer Township meets next week.

Motion made by Vroman, seconded by Boyl to approve the Treasurer's report for December 2018 with corrected ending balance after added expenses of \$179,384.44. Motion carried.

Motion made by Thom, seconded by Kramer to pay township bills of \$7,735.26 for the December 2018 expenses. Motion carried.
