## January 9, 2020 Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 p.m. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Boyl, Sabin. 7 other township residents present.

Motion made by Jobson, seconded by Kramer to approve the minutes of the December 12, 2019 meeting with correction of spelling of Jerald Cook's name. Motion carried.

Motion made by Boyl, seconded by Sabin to approve the Treasurer's report for January 2020 with an ending balance of \$65,937.03 as presented. Motion carried.

Kramer noted that he delivered the road work request forms to the Road Commission for bids.

Kramer reported that County officials mailed a draft copy for review of the new Proposed Animal Control Ordinance. Review by Kramer and the board raised some questions and concerns about some things in it like the proper disposal of dead animals and what number of animals would constitute a kennel and what is adequate shelter? The draft copy did not define these issues or specific wording.

Kramer stated that Rob St. George was considering resigning as Code Compliance Officer effective January 31, 2020. He said that he has one person who has expressed an interest in filling that role.

Sabin noted that he received a letter from Senator Kevin Daily in recognition for accepting the role of Trustee and that a newspaper article also referenced it.

Discussion by the board regarding the Wilkinson Chemical brining contract received. No action taken, tabled until next month meeting.

Kramer stated that Board of Review training will be held at the Tuscola County Skill Center in Caro January 27, 2020, 1-4pm. Nathan Hager will be the Instructor.
