

June 11, 2020
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Sabin and Boyl. 1 other township resident present.

Motion made by Boyl, seconded by Jobson to approve the minutes of May 14, 2020 meeting as presented. Motion carried.

Motion made by Kramer, seconded by Vroman to approve the Treasurer's report for June 2020 with an ending balance of \$91,014.32. Motion carried.

Kramer stated that the road brining was completed last week and that he has not received any complaint calls for the roads.

Kramer stated that there was a hearing for the Log-N-Iron lawsuit and that the case was dismissed by the Judge.

Kramer reported that the Connecting MI Communities Grant project of providing better internet service in rural areas through Air Advantage has been denied.

Kramer reported that the CCO investigated the complaint by Ron Coltson regarding a neighbor directing water onto his property by installing a culvert in an existing driveway back to a pole barn. The complaint has been resolved and the culvert has been removed.

Kramer stated that he received notice from Nathan Hager, Assessor regarding an increase in salary. Discussion by the board followed with recommendation for Kramer to negotiate with assessor and bring to the board next month.

Jobson questioned the Noise Ordinance in regard to whether residents could shoot guns for hours and the loud booming noise. Discussion followed with review of ordinance and quiet time between 11:00 pm to 7:00 am.

Vroman provided information regarding online MTA training courses and subscription options available for township officials.

Vroman reported to the board that he is receiving daily AV ballot applications and that the date for the Public Accuracy Test will be July 27, 2020 at 6:30 pm at the Kingston Village hall.

Motion made by Kramer, seconded by Sabin to pay township bills of \$6,419.34 for June 2020. Motion carried.
