

**June 13, 2019**

**Koylton Twp Board Meeting**

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Boyl and Thom. 12 other township residents present.

Motion made by Boyl, seconded by Thom to approve the minutes of May 9, 2019 meeting as presented. Motion carried.

Motion made by Thom, seconded by Kramer to approve the minutes of the Special Meeting held on May 18, 2019 for land combination for Proski Properties, LLC. Motion carried.

Motion made by Kramer, seconded by Boyl to approve the Treasurer's REVISED report for June 2019 with an ending balance of \$89,218.81. Motion carried. 7/11/19

Supervisor Kramer commented on the drain commission notice, day of review for the Drake Intercounty Drain to be held on June 26, 2019, 9:00 am-5:00 pm, Tuscola County Drain Commissioner's Office, Purdy Building, Suite 100, 125 W. Lincoln St, Caro, MI.

Motion made by Jobson, seconded by Boyl for Sarah Kinel to fill the vacancy on the Board of Review. Motion carried.

Kramer noted that the board is still searching for another person to fill the vacancy on the Planning Commission.

Motion made by Jobson, seconded by Boyl to contract with Nick Osentoski for roadside mowing for 2019 at \$4,900 early season mowing. Motion carried.

Motion made by Boyl, seconded by Jobson to pursue grant for better internet service through Air Advantage, Connecting MI Communities Grant application requirements process and mailing of questionnaire survey. Motion carried.

Motion by Jobson, seconded by Boyl to adopt the Prohibition of Recreational Marihuana Establishment Ordinance 6-19. Motion carried.

**Public Comment:**

Stan Fox asked what was going to be done with the brush piles/tree tops left by Kappen Tree Service.

Jim Borek asked what was being done regarding road work this year. Also, he stated that he thought that the Planning Commission Chairperson should receive \$25 more for each meeting.

Discussion followed regarding road work orders and Cartwright Rd reconstruction issues, i.e. Wetlands and DTE poles to be moved, possible signage to be installed for hill. Also, Kramer stated that road work may not get done this year due to the \$4.2 million-dollar damage to Tuscola County roads caused by rain damage last month.

Road commission work orders were signed for the following roads:

- 1) White Creek Rd between Centerline Rd to Harris Rd, (double chip & seal)
- 2) Mayville Rd between Kingston Rd to Cemetery Rd,
- 3) Cartwright Rd between Kingston Rd to Cemetery Rd,
- 4) Phillips Rd between Mayville Rd to Snover Rd.
- 5) Brief Rd & Denhoff Rd, various patching
- 6) Harris Rd between White Creek Rd to Clothier Rd.

7) White Creek Rd between Mayville Rd to Harris Rd (estimated bid \$170,000)  
 Total work order cost \$138,335 + \$170,000 estimated asphalt.

Report from Ben King regarding progress of roadside tree & brush removal. He is currently working on Mayville Rd, then onto Lanway Rd and Harris Rd.

Motion made by Kramer, seconded by Boyl for approval of land combination of 2 parcels owned by David & Jeanette Kratz on English Rd, parent parcels #016-006-000-1900-00 and #016-006-000-1800-00. Motion carried.
