

May 14, 2020
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Sabin and Boyl. 2 other township residents present and Kim Vaughn County Commissioner.

Motion made by Boyl, seconded by Sabin to approve the minutes of April 9, 2020 meeting as presented. Motion carried.

Motion made by Vroman, seconded by Sabin to approve the Treasurer's report for May 2020 with an ending balance of \$92,875.12. Motion carried.

Kim Vaughn, County Commissioner reported that the County passed a Resolution to re-open the County. Discussion followed.

Kramer stated that he spoke with the Road Commission regarding timing for road grading to begin next week in preparation for brining.

Kramer noted that the township received three bids for roadside mowing this season. The board reviewed and discussed the bids.

Motion made by Boyl, seconded by Jobson to contract with Nick Osentoski, Discrete Diesel, for roadside mowing with a 3-year contract covering 2020-2022 at \$4,650 per 1st cutting each year. Motion carried.

Ron Coltson made a complaint to the board regarding a neighbor directing water onto his property by installing a culvert in an existing driveway back to a pole barn. Kramer stated that he would refer complaint to the Code Compliance Officer to investigate.

Vroman reported to the board regarding the upcoming elections and potential for high AV ballots. Discussion regarding dates for the Public Accuracy Test were reviewed.

Boyl reported that the Planning Commission meetings are on hold for now and that they have been reviewing the Townships Master Plan.

Motion made by Jobson, seconded by Boyl to pay township bills of \$5,538.93 for May 2020. Motion carried.
