Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:00 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Sabin and Boyl. 1 other township resident present.

Motion made by Jobson, seconded by Boyl to approve the minutes of September 15, 2020 meeting as presented. Motion carried.

Motion made by Boyl, seconded by Sabin to approve the Treasurer's report for October 2020 with an ending balance of \$60,203.21. Motion carried.

Review and discussion of tabled letter presented last month by Ron Coltson from Marlette Township Boards Attorney regarding Medical Marijuana. The Boards opinion was that the letter does not apply to our township based upon the fact that our township does not have any current or proposed licensed medical marijuana dispensaries.

The Election Ballot Drop Box has been set up and secured for residents to drop off their absent voter ballots. Thank you to Lisa Brett for the lettering and Jeremy Rayl for setting up and securing the drop box to the cement pad.

Kramer stated that the gravel roads were brined a second time and that the Road Commission may not finish the gravel road projects this year due to lack of gravel being processed at the pits.

Vroman stated that the Public Accuracy Test for ballots will be October 26th at 6:30 at the Kingston Village Hall.

Boyl stated that Nicole Friday is retyping the Master Plan.

Motion made by Kramer, seconded by Jobson stating that all property tax payments will be considered paid as of the date when received by the Township Treasurer. Motion carried.

Vroman stated the King and King CPA's were going to prepare and file the F-65 Report for 2020.

Motion made by Kramer, seconded by Boyl to pay township bills of \$26,791.18 for October 2020. Motion carried.
