

September 15, 2020
Koylton Twp Board Meeting

The regular Koylton Twp meeting was called to order by Supervisor Doug Kramer at 7:05 pm. Pledge to the Flag. Board Members present: Kramer, Vroman, Jobson, Sabin and Boyd. 1 other township resident present.

Motion made by Boyd, seconded by Sabin to approve the minutes of August 8, 2020 meeting as presented. Motion carried.

Motion made by Kramer, seconded by Vroman to approve the Treasurer's report for September 2020 with an ending balance of \$86,754.43. Motion carried.

Ron Coltson presented a letter for the boards review from Marlette Township Boards Attorney regarding Medical Marijuana. Board to review and discuss next month.

Boyd stated that no one has come to the Planning Commission or filed with the State for a medical marijuana license in Koylton Township.

Vroman stated that the applications for PA116 from Michael Fischer were approved by the Tuscola County Planning Commission and Conservation District and will be mailed on to the State MDARD Farmland and Open Space Program for final recording.

Kramer reported that the CCO has been working on different sites regarding blight and abandoned vehicles and has made some progress.

Ron Coltson reported that the Marlette Fire Authority is now all paid up on billed invoices to DTE and have renewed their loan with Independent Bank at the same interest rate.

Motion made by Vroman, seconded by Kramer to have King and King CPA's prepare and file the 2020 Qualifying Statement form 5047 and pay their fee of \$175.

Discussion regarding the election ballot drop box received from the State on placement and approval from the village. Kramer to inquire with the village and request approval for placement.

Vroman stated that the FOIA requests for election records was officially withdrawn.

Motion made by Boyd, seconded by Jobson to pay township bills of \$5,521.06 for September 2020. Motion carried.
